Welcome to Spring!!! Our new chapter in the life of Lakewood Village Community has begun! There are many changes that will be taking place in our community.

- There will be an Easter Egg Hunt for the children on April 20, please bring your children and enjoy!!

Please be advised that we **ARE** taking a stronger stance on the inspections; from this point forward if you do not comply with the letter received or contact the office your file WILL BE sent to the attorney for eviction or foreclosure for non-compliance. If the home needs to be weeded or pressure washed and this is not completed then it will be done by the Association and the fees will be passed on to the resident. If the fees aren't paid, the amount will be sent to attorney for non-payment.

Summit Communities is planning on bringing new homes into the Community to try and fill the many vacant lots we have, but when houses are left a mess and not maintained; it makes that task much harder to achieve. ## **SELLING YOUR HOME**

#### 1. AN INTENT TO SELL MUST BE FILLED OUT.

- 2. The ARC committee will do a review of the property and notify the homeowner of anything that needs to be done before selling the property.
- 3. Any perspective buyer must come to the office and fill out the application for residency. There is a \$50.00 fee per adult. Part of the application is the credit history and criminal background check, which is done by the office, prior to purchasing the home. The prospective new residents must be approved by the interview committee and the BOD.
- 4. The title to the mobile home should be transferred immediately to the new owner once approved and the closing is complete.



## FOUR LEGGED PETS

ALL FOUR -LEGGED PETS OVER THE AGE OF 4 MONTHS MUST BE LICENSED. IT IS UNLAWFUL TO ALLOW PETS TO RUN AT LARGE (OFF THE PROPERTY OF THE OWNER) THIS INCLUDES ALL DOGS AND CATS, **KEEPING A HABITUALLY LOUD BARKING, YELPING OR HOWLING** DOMESTIC PET IS UNLAWFUL. THE FLORIDA STATUTE ALOWS THE PARK TO FINE UP TO \$100.00 PER VIOLATION
